# DRUG ENFORCEMENT ADMINISTRATION (DEA) CHEMICAL DIVERSION AND TRAFFICKING ACT OF 1988

Dear Customer:

The DEA is enforcing the Chemical Diversion and Trafficking Act of 1988 which requires each vendor or "regulated person", as defined in this Act, to maintain records and reports of "listed chemicals and certain machines" which are sold, purchased, or delivered between individuals, corporations, partnerships, associations, or other legal entities. For your reference, we are enclosing the DEA List (Page 3) of chemicals that are subject to federal requirements under the Control Substance Act.

Among the requirements imposed on Sellers by the Act, are the following:

- 1) The seller must keep records of the buyer to verify that this is a viable business operation. The seller must also keep records of the date, quantity, and method of transfer.
- 2) The seller must report to the DEA any suspicious purchases and/or unusual or excessive losses of listed chemicals.
- 3) Importers and exporters of the listed chemicals are required to keep certain records and make certain reports.

In connection with the first requirement, The Plaza Group must have on file a list of your personnel authorized to order the listed chemicals from The Plaza Group. The list should include <u>all</u> of your authorized personnel who may <u>ever</u> place an order for any of the chemicals listed.

### **NOTICE**

The following chemicals and their salts, isomers and salts of optical isomers in threshold amounts, are subject to Federal Requirements under the Controlled Substances Act as amended by the Chemical Diversion and Trafficking Act of 1988 (CDTA) and the Domestic Chemical Diversion Control Act of 1993 (DCDCA).

List I Chemicals were formerly titled "precursor chemicals" and List II chemicals were titled "essential chemicals". List I and List II chemicals apply to both CDTA and DCDCA.
